12 THE COURT: THE CASE IS SET FOR TRIAL SETTING
13 CONFERENCE. WHAT ARE THE ISSUES?

14 MS. SMITH: WELL, THE ISSUE IS GOING TO BE --
15 ACTUALLY, I THOUGHT RESPONDENT WAS HERE IN PRO PER.

16 THE COURT: I DID HAVE A NOTE THAT RESPONDENT WAS
17 HERE.

18 MS. GIBSON?

19 (A PAUSE IN THE PROCEEDINGS.)

20 THE COURT: ARE YOU MS. GIBSON?

21 THE RESPONDENT: HI. HOW ARE YOU?

22 THE COURT: I CALLED YOUR MATTER.

23 THE RESPONDENT: I'M SORRY, SO SORRY.

24 THE COURT: CAN YOU STEP FORWARD AND STATE YOUR
25 NAME FOR THE RECORD.

26 THE RESPONDENT: KARRIE GIBSON. I'M GOING TO GRAB
27 MY STUFF, IF THAT'S OKAY?

28 (A PAUSE IN THE PROCEEDINGS.)

1 THE COURT: SO THE CASE IS SET FOR TRIAL SETTING
2 CONFERENCE. I WAS JUST ASKING COUNSEL BEFORE YOU GOT
3 HERE, MS. GIBSON, WHAT THE ISSUES WERE?

4 THE RESPONDENT: WHO'S THE COUNSEL?

5 THE COURT: THE WOMAN AT THE TABLE RIGHT NEXT TO
6 YOU.

7 THE RESPONDENT: I'M SORRY, SO SORRY, MA'AM. I
8 HAVEN'T HAD THE PLEASURE.

9 THE COURT: WE'RE IN A HEARING NOW. SO YOU CAN
10 HAVE THE SMALL TALK AFTERWARDS. I WANT TO KNOW WHAT THE
11 ISSUES ARE FOR TRIAL IN YOUR CASE. I'M GOING TO START
12 WITH COUNSEL BECAUSE SHE REPRESENTS PETITIONER. AND
13 THEN I'LL TURN TO YOU.

14 THE RESPONDENT: CAN I SIT DOWN?

15 THE COURT: PLEASE.

16 MS. SMITH: GOOD MORNING, YOUR HONOR. WE SUBBED
17 IN DECEMBER 13TH. THE ISSUES THAT WE SEE WOULD BE
18 SPOUSAL SUPPORT FILED BY RESPONDENT. I BELIEVE THERE'S
19 ALSO PROPERTY DIVISION AS WELL AS THERE'S TWO REQUESTS
20 FOR ORDERS ON CALENDAR, ONE FOR A VOCATIONAL EVALUATION,
21 AND THEN WE JUST SAW ONE AS OF LAST WEEK FOR ATTORNEY'S
22 FEES.

23 THE COURT: BOTH FILED BY -- ONE FILED BY YOU, ONE
24 FILED BY RESPONDENT?

25 MS. SMITH: CORRECT.

26 THE COURT: ARE THEY SET FOR THE SAME DAY?

27 MS. SMITH: NO. ONE IS SET FOR, I BELIEVE,
28 FEBRUARY 7, AND THE OTHER IS -- THERE'S TWO IN MARCH,

1 MARCH 13 AND 14.

2 THE COURT: SO THREE RFO'S OR TWO RFO'S?

3 MS. SMITH: THERE'S TWO. BUT PER THE REGISTER OF
4 ACTION, I SEE THREE DATES.

5 THE COURT: SO IS THAT YOUR -- IS THAT A FAIR
6 STATEMENT OF THE ISSUES FOR TRIAL? SPOUSAL SUPPORT AND
7 PROPERTY DIVISION?

8 THE RESPONDENT: YOUR NAME IS JUDGE HEIDEL?

9 THE COURT: UH-HUH.

10 THE RESPONDENT: I'D LIKE TO PREFACE THIS WITH
11 SAYING TO YOU THAT I'M EXPERIENCING SOME HEALTH ISSUES.
12 SO I RECENTLY WAS IN AN ACCIDENT, AND I HAVE A
13 CONCUSSION. SO IT TAKES ME A LITTLE LONGER TO PROCESS
14 WHAT YOU'RE SAYING. SO IF YOU COULD BE PATIENT WITH ME.

15 I'M NOT REALLY CLEAR WHAT THE PURPOSE OF
16 THIS -- I NEED SPOUSAL SUPPORT BECAUSE JAMES JUST LEFT
17 AND HE ABANDONED ME WITHOUT PAYING.

18 THE COURT: THE PURPOSE OF THE HEARING IS TO
19 IDENTIFY THE ISSUES FOR TRIAL. NOT TO TALK ABOUT THE
20 MERITS OF THOSE ISSUES, JUST TO IDENTIFY THE ISSUES THAT
21 THE PARTIES NEED RESOLUTION ON. AND THEN WE'LL SET A
22 TRIAL DATE TO RESOLVE THEM.

23 THE RESPONDENT: I WAS KIND OF GETTING TO THAT.
24 I'M NOT PREPARED TO SET A TRIAL DATE. I NEED
25 REPRESENTATION. WHEN I -- I WAS -- I WAS UNDER THE
26 IMPRESSION THAT JAMES WAS GOING TO HANDLE HIMSELF. I
27 RECEIVED NOTICE THAT HE HAD AN ATTORNEY LIKE TWO WEEKS
28 AGO. AND TO BE QUITE HONEST WITH YOU, I THOUGHT WE WERE

1 GOING TO RESOLVE OUR ISSUES. WE WERE SUPPOSED TO GO TO
2 THERAPY.

3 THE COURT: YOU THOUGHT YOU WERE GOING TO
4 RECONCILE?

5 THE RESPONDENT: WELL, I FELT LIKE WE WERE MOVING
6 TOWARD THAT DIRECTION. WE WERE SUPPOSED TO DO THERAPY,
7 WHICH HOPEFULLY WAS GOING TO LEAD TO THAT.

8 THE COURT: I SEE. WELL, THAT'S -- I DON'T KNOW
9 IF THAT'S A POSSIBILITY. BUT IT'S CERTAINLY -- NOTHING
10 WE'RE DOING TODAY WOULD PREVENT THAT. SO YOU CAN STILL
11 DO THAT.

12 OKAY, SO ASSUMING THERE IS NO
13 RECONCILIATION, YOU HAVE A REQUEST FOR SPOUSAL SUPPORT.
14 AND THEN DO THE PARTIES HAVE PROPERTY?

15 THE RESPONDENT: WE DO.

16 THE COURT: WHAT KIND OF PROPERTY DO THE PARTIES
17 HAVE?

18 THE RESPONDENT: WE OWN A HOME. AND MY HUSBAND
19 HAS PROPERTY. HE HAS OTHER -- HE HAS PROPERTY. I DON'T
20 KNOW, ARE YOU REFERRING TO PHYSICAL PROPERTY OR
21 FINANCIAL PROPERTY AS WELL?

22 THE COURT: BOTH. YEP.

23 THE RESPONDENT: THAT'S LIKE ONE OF THE ISSUES.
24 BECAUSE I DIDN'T HAVE REPRESENTATION, I DON'T KNOW THE
25 PROCESS TO DISCOVER WHAT HE HAS AND WHAT -- HE HASN'T
26 BEEN TRANSPARENT FOR A VERY LONG TIME.

27 THE COURT: IS THERE ANYTHING -- WHEN DID YOU
28 SUFFER THE CONCUSSION?

1 THE RESPONDENT: I WAS REAR-ENDED ON DECEMBER 7TH,
2 BUT THAT'S PART OF THE PROBLEM. I BROUGHT MY MEDICAL
3 RECORDS. I HAD A SEVERE BACK INJURY WHERE I HAD
4 SURGERY. AND I HAVE ALL MY RECORDS --

5 THE COURT: WHEN?

6 THE RESPONDENT: FOR THE PAST EIGHT YEARS, I'VE
7 BEEN ON MEDICATION THAT'S CAUSING -- AFFECTING MY
8 COGNITIVE SKILLS. SO I CAN THINK AND FUNCTION, IT JUST
9 TAKES ME A LITTLE LONGER. SO I APPRECIATE A LITTLE
10 PATIENCE.

11 THE COURT: OKAY. WHEN DID YOU SUFFER THE
12 CONCUSSION?

13 THE RESPONDENT: THE CONCUSSION, AS OF RECENTLY,
14 IT WAS DECEMBER 7TH. I THINK I WAS REAR-ENDED DECEMBER
15 7TH.

16 THE COURT: ALL RIGHT. WELL, WHAT COUNSEL IS -- I
17 THINK IS ASKING FOR IS TO CONTINUE THE TRIAL SETTING
18 CONFERENCE TO A DATE OF AT LEAST ONE OF THE RFO'S
19 ALREADY SET. YOU FILED A REQUEST FOR ORDER FOR
20 ATTORNEY'S FEES; CORRECT?

21 THE RESPONDENT: UH-HUH.

22 THE COURT: DID YOU FILE ANOTHER ONE?

23 THE RESPONDENT: I'M NOT -- TO BE QUITE HONEST
24 WITH, YOU MA'AM, I'M LIKE OPERATING IN THE DARK. WHEN
25 HE FIRST SERVED ME AND I RESPONDED, I WENT TO THE
26 SELF-HELP. I DID NOT HAVE MY TAXES. SO THEY DIDN'T
27 HELP ME. SO I PRETTY MUCH JUST COPIED WHAT HE HAD. I
28 DIDN'T KNOW THAT I NEEDED TO ASK FOR SPOUSAL SUPPORT.

1 FOR ME, THAT'S PRIORITY. MY SON IS PAYING FOR
2 EVERYTHING. I'M GETTING DEEPER AND DEEPER IN DEBT.

3 JAMES LEFT IN JANUARY. AND HE LEFT AND PUT
4 ALL THE UTILITIES IN MY NAME. AND SO FOR ME TO ADAPT, I
5 NEED SPOUSAL SUPPORT WHICH WILL AID ME IN GETTING PROPER
6 REPRESENTATION, BECAUSE THE QUESTIONS YOU'RE ASKING ME,
7 I'M REALLY IN THE DARK ABOUT HOW TO PROCEED. I'VE
8 LEARNED BY TALKING TO SOMEONE, TO SOME ATTORNEYS, AND
9 JUST GOOGLING THINGS ON THE INTERNET.

10 THE COURT: I'M GOING TO MAKE THE COMMENT YOU SEEM
11 TO BE VERY LUCID AT TIMES AND THEN YOU SLOW DOWN YOUR
12 SPEECH A LOT AND SEEM MORE CONFUSED WHEN YOU TALK ABOUT
13 YOUR INJURIES. I'M NOT SURE WHAT'S GOING ON WITH YOU,
14 BUT IT'S NOTICEABLE.

15 THE RESPONDENT: YOU KNOW, I DIDN'T QUITE CATCH
16 THAT?

17 THE COURT: WHAT IS THE DATE SET FOR HEARING ON
18 THE REQUEST FOR SPOUSAL SUPPORT?

19 THE CLERK: FEBRUARY 7.

20 THE RESPONDENT: SEE --

21 THE COURT: THAT IS -- HOLD ON. THIS IS THE
22 HEARING DATE ON YOUR REQUEST FOR SPOUSAL SUPPORT.
23 THAT'S FEBRUARY 7 --

24 THE RESPONDENT: THAT IS WHAT I'M --

25 THE COURT: YOU FILED A REQUEST FOR SPOUSAL
26 SUPPORT?

27 THE RESPONDENT: I DID, MA'AM.

28 THE COURT: AND THERE'S GOING TO BE A HEARING ON

1 THAT REQUEST ON FEBRUARY 7TH.

2 THE RESPONDENT: I APPRECIATE THAT. AND I'M A
3 LITTLE CONFUSED ABOUT YOUR COMMENT. I'M REALLY
4 CONFUSED. BUT THAT'S WHY I PREFACE THAT BECAUSE I WANT
5 TO BE CLEAR, AND I HAVE CONCERNS ABOUT COHESIVENESS IN
6 MY SPEECH.

7 WHEN I DID -- I RESPONDED TO YOU -- I SPOKE
8 ABOUT RESPONDING TO HIS FIRST INITIAL FILING. AT THAT
9 TIME, MY UNDERSTANDING, I WAS SUPPOSED TO SELECT SPOUSAL
10 SUPPORT. BUT I SELECTED ALIMONY, BECAUSE I JUST COPIED
11 HIS PAGE. WHAT HE DID, I COPIED, BECAUSE I HAD NO HELP.

12 THE COURT: OKAY. WELL, I DON'T KNOW THAT IT
13 MAKES ANY DIFFERENCE. I'M NOT DECIDING ANYTHING. I'M
14 JUST TELLING YOU THERE'S A HEARING DATE. THERE'S
15 NOTHING REALLY TO DISCUSS RIGHT NOW.

16 THE RESPONDENT: THAT'S WHAT I WANT -- WHAT I'M
17 ASKING.

18 THE COURT: YEAH. I KNOW.

19 THE RESPONDENT: AN ATTORNEY TOLD ME I NEED TO GO
20 MAKE AN AMENDMENT. SELF-HELP TOLD ME IF I BROUGHT IT TO
21 YOU TODAY -- I DON'T HAVE AN INCOME. I'M GETTING DEEPER
22 AND DEEPER IN DEBT.

23 THE COURT: IT'S SET FOR FEBRUARY 7TH.

24 THE RESPONDENT: YOU'RE NOT WILLING TO LISTEN
25 TODAY?

26 THE COURT: I'M NOT ABLE TO. THERE'S NOT PROPER
27 NOTICE TO THE OTHER PARTY ABOUT A REQUEST --

28 THE RESPONDENT: HE DIDN'T GET SERVED?

1 THE COURT: HE DID, BUT HE WAS SERVED A NOTICE FOR
2 FEBRUARY 7, 2019. SO THAT'S THE DAY WE'RE GOING TO HAVE
3 THE SPOUSAL SUPPORT HEARING. AND WE WILL CONTINUE THE
4 TRIAL SETTING CONFERENCE TO THAT DATE.

5 AND THEN WE WILL PROCEED FROM THERE, OKAY?
6 IF YOU NEED TO HIRE AN ATTORNEY IN ADVANCE OF THAT
7 HEARING, I WOULD ENCOURAGE YOU TO DO THAT.

8 THE RESPONDENT: YOU KNOW, I'M SORRY. I'M -- THIS
9 IS REALLY VERY HARD FOR ME BECAUSE WHAT YOU'RE SAYING TO
10 ME IS IN CONFLICT WITH WHAT I'M TO UNDERSTAND. WHEN I
11 WENT TO THE SELF-HELP, THEY TOLD ME THAT YOU WOULD
12 DISCUSS IT THEN. YOU WANT TO DO A TRIAL SETTING DATE ON
13 FEBRUARY 2ND (SIC), AND I DON'T HAVE AN ATTORNEY. I'M
14 BARELY PAYING MY BILLS. I -- JAMES HAS DONE SO MUCH
15 STUFF, MA'AM. HE'S HID MONEY. HE'S PUT DIFFERENT
16 PEOPLE'S NAME ON MONEY. I DON'T HAVE THE RESOURCES OR
17 THE EDUCATION TO DEFEND MYSELF.

18 TODAY, FOR ME, PRIORITY IS SPOUSAL SUPPORT
19 SO I CAN MOVE TOWARDS HIRING SOMEONE. THE LADY
20 DOWNSTAIRS TOLD ME TO COME AND BRING YOU THE PROPOSALS
21 FROM THE ATTORNEYS. I'VE TALKED TO SOME BUT I DON'T
22 HAVE A RETAINER FEE.

23 THE COURT: WELL, THAT'S JUST NOT BEFORE THE COURT
24 TODAY. MY HANDS ARE TIED. I CAN'T MAKE A RULING ON
25 SPOUSAL SUPPORT WHEN IT HASN'T BEEN PROPERLY NOTICED FOR
26 TODAY. THIS HEARING WAS SET, AND IT'S JUST TO DECIDE
27 WHEN TO SET THE TRIAL. YOU ALL ARE NOT READY TO SET
28 TRIAL. I CAN TELL THAT FROM THE CONVERSATION. SO WE'RE

1 NOT GOING TO DO THAT. WE'RE GOING TO CONTINUE THE TRIAL
2 SETTING CONFERENCE.

3 YOU MADE A REQUEST FOR SPOUSAL SUPPORT. YOU
4 SERVED MR. GIBSON. AND THAT WILL BE HEARD FEBRUARY 7TH.

5 THE RESPONDENT: OKAY. SO --

6 THE COURT: I'M GOING TO GIVE YOU ONE MORE COMMENT
7 BECAUSE I HAVE TO MOVE ON TO SOME OTHER CASES. THIS
8 ISN'T REALLY A HEARING ON ANY KIND OF MERITS OF ANYTHING
9 TODAY.

10 THE RESPONDENT: I UNDERSTAND, MA'AM. I'M HOPING
11 YOU WOULD BE PATIENT WITH ME. FOR ME, IT'S EDUCATION.
12 I MADE ZERO DOLLARS, AND MY HUSBAND MAKES \$200,000 A
13 YEAR. I'M A MOM, AND I TOOK CARE OF MY KIDS. I'M HERE
14 AND THE QUESTIONS, SO I CAN UNDERSTAND --

15 THE COURT: THAT'S FINE. I'M HAPPY TO ANSWER YOUR
16 QUESTIONS.

17 THE RESPONDENT: SO WHAT I'M UNDERSTANDING IS THAT
18 YOU'RE GOING TO MOVE THE SPOUSAL SUPPORT TO FEBRUARY?

19 THE COURT: NO. I'M NOT MOVING IT. IT WAS ALWAYS
20 SET --

21 THE RESPONDENT: OKAY. IT WILL REMAIN AS IT IS.
22 I'M SO SORRY. I KNOW IT SOUNDS UNCLEAR. BUT I GOT
23 INFORMATION FROM THE DIFFERENT PEOPLE THAT I TALK TO.
24 THE PEOPLE UPSTAIRS SAID YOU WOULD TELL ME -- YOU WOULD
25 DISCUSS IT TODAY. THE GIRL DOWNSTAIRS, YOU WOULD
26 DISCUSS IT TODAY. AND VERONICA (PHONETIC) TOLD ME TO DO
27 THE ORDERS TO ENSURE IT'S IN THE SYSTEM.

28 THE COURT: I DON'T KNOW WHO ANY OF THOSE PEOPLE

1 ARE. I'LL TELL YOU THIS, SELF-HELP DOES NOT GIVE LEGAL
2 ADVICE. THE CLERK'S OFFICE DOES NOT GIVE LEGAL ADVICE.
3 IF YOU NEED LEGAL ADVICE, YOU'LL HAVE TO FIND AN
4 ATTORNEY WILLING TO TAKE YOU ON WITHOUT A RETAINER. BUT
5 WE'RE NOT GOING TO DO SPOUSAL SUPPORT TODAY AND NOTHING
6 WILL BE --

7 THE RESPONDENT: THAT'S FINE. I'M CLEAR ON THAT.
8 MY NEXT ORDER OF BUSINESS IS YOU'RE SAYING YOU WANT TO
9 DO A TRIAL SETTING ON FEBRUARY? I WON'T BE PREPARED FOR
10 A TRIAL SETTING ON FEBRUARY, BECAUSE I'M NOT GOING TO
11 HAVE AN ATTORNEY IN FOUR WEEKS. I DON'T HAVE INCOME.
12 I'M BARELY ABLE TO PAY MY BILLS.

13 THE COURT: ALL WE'RE DOING IS CONTINUING THIS
14 HEARING TO THE SAME DAY YOU'RE ALREADY GOING TO BE HERE.

15 THE RESPONDENT: WHEN YOU TALK ABOUT TRIAL
16 SETTING, THAT WOULD BE CONSIDERED THAT WE'VE ASKED YOU
17 THE MERITS OF THE CASE AND EVERYTHING THAT IS EXPECTED
18 IN TERMS OF I'VE BEEN MARRIED FOR 25 YEARS. THERE'S A
19 LOT INVOLVED IN THIS.

20 THE COURT: BUT YOU ALREADY KNOW YOU WANT --
21 THERE'S CERTAIN PROPERTY YOU WANT TO SPLIT AND YOU WANT
22 SPOUSAL SUPPORT. YOU ACTUALLY KNOW EXACTLY WHAT THE
23 ISSUES ARE. YOU MAY NOT KNOW ALL THE PROPERTY, BUT YOU
24 SEEM TO BE -- TO HAVE A PRETTY GOOD IDEA OF WHAT THE
25 ISSUES ARE FOR TRIAL. WHETHER OR NOT YOU'RE READY TO GO
26 TO TRIAL, WE'LL FIND OUT FEBRUARY 7.

27 SO WE'LL CONTINUE THIS HEARING TO FEBRUARY
28 7TH. YOU'RE GOING TO BE HERE ANYWAY. WE'LL HAVE THE

1 HEARING AT THAT TIME ON THE REQUEST FOR SPOUSAL SUPPORT.
2 AND WE'LL GO FROM THERE.

3 MS. SMITH: YOUR HONOR, QUESTION, CAN YOU CLARIFY
4 IF THE FEBRUARY 7TH WILL ALSO BE THE VOCATIONAL
5 EVALUATION RFO OR IF THAT'S THE MARCH DATE? BECAUSE
6 THAT'S RELATED TO SPOUSAL AS WELL.

7 THE RESPONDENT: CAN I RESPOND TO THAT?

8 THE COURT: IT'S JUST A REQUEST TO WHAT DATE THE
9 HEARING IS. IT'S NOT REALLY ASKING FOR A RESPONSE.
10 THAT WILL BE THE 13TH.

11 MS. SMITH: MARCH 13TH?

12 THE COURT: UH-HUH.

13 THE RESPONDENT: MY QUESTION IS WHAT SHE'S
14 REFERRING TO. THAT'S WHAT I'M SAYING. I NEED AN
15 ATTORNEY. I DON'T KNOW WHAT MY RIGHTS ARE REGARDING
16 THAT.

17 I'M BEING REQUESTED TO TAKE A TEST?

18 THE COURT: OKAY. WE'RE GOING TO HAVE TO CONTINUE
19 THIS CONVERSATION ON THE 7TH. SEE YOU FEBRUARY 7TH.

20 MS. SMITH: THANK YOU, YOUR HONOR.

21 THE COURT: THANK YOU.
