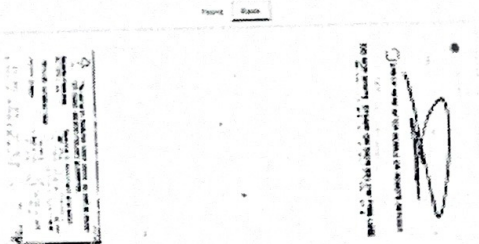

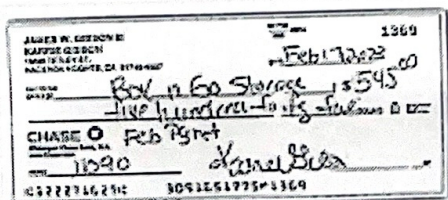

My name is Karrie Gibson. Sometime in 2020 Box n Go received property that was stolen from my home around December of 2020. I have communicated to Box n Go that I never authorized Box n Go to receive my property and my son's property.

My first request is to provide the legal name of the business whose dba is Box-n-Go. I have asked Freddy Ortiz multiple times for the owner's contact and legal name. He refused.

Attached you will find a copy of the emails I sent to Box N Go certified around Feb- March of 2021. Someone from Box n Go left my son, Sterling Scarborough a message that you illegally accepted Sterling Scarborough and Karrie Gibson's property. I have on multiple occasions explained to Box n Go that they didn't have authorization to receive my property. This happened during Covid where there were Covid Mandates.

I am going to begin by saying I believe Freddy Ortiz is attempting to steal my property. I suspect that your company has already sold parts of my belongings. One of the storage units is missing on one of the invoices. When I mentioned it, it was corrected. Again, I have documented every aspect of this illegal ordeal. My son has all the voicemails on his phone. You are aware that the property is stolen, and you received my things illegally. I have only made payment to prevent my property from being damaged or lost.

Attached you will find the video documentation. The video dated March 9, 2023 Frank transferred me to a voicemail.

1. 1st video is me talking to Frank.
2. 2nd video is me calling back and getting a voicemail
3. The 3rd video is with Freddy, who I believe is trying to steal my property. In the video he claims that he contacted James Gibson. In the video he claims that he spoke to James either via phone or email. In the video he claims that James Gibson told him that James Gibson gave me the message. James Gibson is being copied on this correspondence. I have not had any conversations with James Gibson since 2021.

After speaking to Frank around March of 2023 I have not received any invoices from you. Attached is a screenshot demonstrating that you stopped sending invoices.

Details of evidence

Attached are email to sales@Boxngo.com Emails that were never acknowledged.

1. Email dated January 2, 2023. I address the fact that I mail the check before the 20th, but you wait over 10 days to cash the check.
2. March 9th 2023 is the email where I address the voicemail. I have not received any response. Each time that I email and or left a voicemail.

This is my belief. I believe that you purposely cash my check late to run the bill. Then you create these bogus fees. I think I am not the only one you've done this to. I spoke to the owner in the summer of 2021. He was very nice. He told me he understood and he would work with me. He sounded like an elderly man. This might possibly be a case of elderly abuse. Each time I asked to speak to the owner Freddy was nasty. Frank appeared less confrontational. Frank I also have a video where you said no they are not going to sell my things. I will present that evidence in the future.

3. Also attached in May's invoice according to the invoice I owed \$533, I was given a \$20. courtesy credit If my invoice is \$533 for May 7th payment

Freddy Ortiz I think you are doing something illegal and scandalous you don't provide the legal name of this company. I will do a business license search.

I am going to contact the local District Attorney and the news to investigate your unethical business practice.

Again, I have never received a call back or a return email.

James Gibson, they are trying to say I owe them \$2815.

PS I HAVE BLIND COPY MULTIPLE NEWS ORGANIZATION IN HOPES THE WILL INVESTIGATE BOX N GO FRAUD.

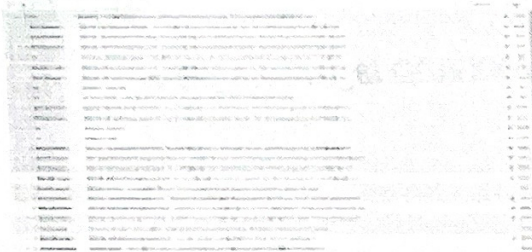

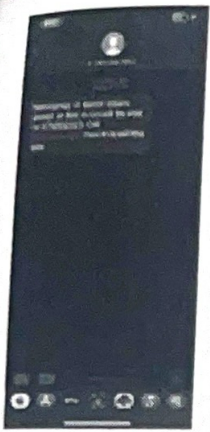

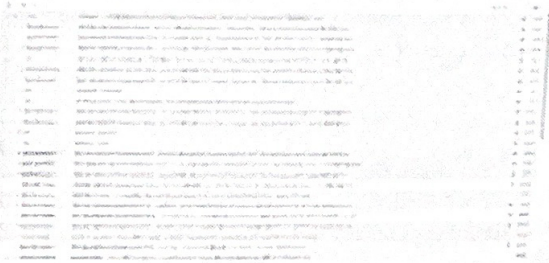
