## Declaration

Sterling Scarborough

Karrie Gibson

July 24, 2023

On September 23, 2020, four City Of Industry Sheriff broke in to the home I shared with my mother, Karrie Gibson. My mother captured the violation of the 4<sup>th</sup> Amendment illegal search seizure of my residence and my mother's marital home. This was the height of Covid. There was stay at home mandate. At the height of Covi 19. Four sheriff deputy's illegals put my mother and I in the street. My mother was terrified for our lives. We sort shelter in a local hotel. My credit score dropped 100 points because I had to pay for the room. I made arrangement with a creditor, which negatively influenced my credit. The hotel is infested with bed bugs. I am a gig worker. I work 10 hour a day to keep my mother and I in the hotel. James Gibson illegally took possession of the home, changed the locks.

Sometime in February or March of 2021 I received a voicemail from someone name Frank stating they have my property and my mother Karrie Gibson. Box N Go illegally took possession of my property and my mother's property. The home was 2700 square feet, all my and my mother possessions were illegal places in storage. Box N Go acknowledging excepting my property and my mother's property. My mother and I are living under extreme conditions. My mother is under the care of multiple doctors. My mother lived in an extremely abusive marriage for over 23 years. My mother sustained a severe back injury in 2008, in 2016 she had back surgery. My mother, Karrie Gibson to pain killers from 2008 until 2016 after a successful back surgery. My mother and I are victims of anti-black hate crimes, and fraud. My mother is currently waiting to hear back about a disability claim. *See exhibit A*, Written correspondent from Karrie Gibson's therapist explaining her condition. Gibson's doctor told her to put the legal battles on hold, that she should work on healing. The therapist explains her medical condition. My mother sent a certified letter to Box n Go, explaining that they illegal took possession of our property, that she didn't believe she had a contractual obligation with Box N Go. Karrie Gibson states that she would make the monthly payments in go faith, to resolve the issues through the court. My mother is suffering from severe depression, anxiety, insomnia, and fatigue. She and I endure living in this bed bug and roach infested room. My mother filed a formal complaint with the Public Health Department, the health department is currently investigating. The report numbers are CO0373615 and CO0375622. *See Exhibit B* photos bugs bites to me and my mom's body. My mom and I never saw our property again. My mother doesn't have transportation and I work every day. My mom has made monthly payments, she even adheres to the price increase which we question the legality. In summer of 2022 my mother began to notice her checks were taking abnormally long too clear. *Exhibit C* email sent August 19, and Aug 25<sup>th</sup> 2022. My mother is questioning why it is taking so long to cash the checks. She sent 2 requests but never received a response. Again, my mother is noticing Box N Go taking excessively long to cash the checks. *See Exhibit C* the email to [Sales@boxngo.com](mailto:Sales@boxngo.com) email received by Freddy Ortiz. Email dated Jan 2, 2023. My mother, Karrie Gibson states that she mailed a check from Hacienda Heights, to Commerce, Ca. Check was mailed on Dec 16<sup>th</sup>, on Jan 2, 2023 the check hasn't cleared. In the correspondence she reminds Box N Go knowingly they illegally received property from James Gibson, remind them about the certified letter sent April 2021.



Around March/April of 2023 I received another voicemail implying the account was delinquent. My mother documented a call to Box N Go via video. She informs Frank the call is being video recorded. Frank answered the phone, stated Freddy must have left the message. When my mother attempted to discuss the account, Frank transfers the call to Freddy. Freddy sends her to voicemail. She calls back a 2<sup>nd</sup> time being sent in voicemail. No one every answered. My mother, Karrie Gibson documented to the phone call. *Exhibit AA* is the first video is a call to Frank, *Exhibit AB* is video of second call to Box N Go documenting my mother receiving voicemail.

On July 11, 2023, I received text message saying Karrie Gibson's property would be auctioned on July 26<sup>th</sup>. I forwarded the text to my mother Karrie Gibson. My mother called Box N Go. *See Exhibit D* copy of text message. Karrie Gibson video recorded the call, Freddy states that we owe \$2815. Freddy Ortiz is recorded lying, trying to extort my mother for \$2815. He says that we struggled with paying the bill. Blatantly lying threatening to put our property up for auction. He emails my mother a frequently audit, that says our balance is \$2814. My mother did a search of Box N Go on here mail. She realized that Box N Go stopped sending invoices after the video recording conversation. *See Exhibit E* A screenshot search results when searching Box N Go in her email account. *See exhibit F* fraudulent account audit. My mother has never missed a payment. *See Exhibit G* April 27<sup>th</sup> invoice. States Last payment \$545 Account Balance \$553. There is a \$20 incentive credit applied in April. *Exhibit H* are invoices 11/28/22, 1/28/23, 3/28/23 each invoice confirms the account is current balance.

My mother sends 3 subsequent emails July 12 *Exhibit I* Box N Go has never responded via email. My son has only received voicemails that were transcribed to text message. *See Exhibit J* screenshot of a search of check from 2 different of my mother accounts. Checking account ending in 8811 and 1775. My mom paid from either account each month. Box N Go was virtually the owner business she wrote checks. *See Exhibit K* Copy of canceled number 526, written March 15<sup>th</sup> see posted date 3/31/23. Checks April 17, check number 527 See check was written on April 17<sup>th</sup> See check didn't post until 5/18/23  
Check number 528, written on May 19, 2023, posted 6/08/23. My mother is mailing from 91744 to 90091

My mother and I fear that our property has been sold or damaged. We recognize that there was a Covid mandate regarding storage fees, and eviction. Box N Go is committing fraud I suspect we aren't the only ones who are victims of Box N Go They knowingly received my property. My mother was forced to obtain another storage facility. She was told that only one person can enter into storage agreement. I Sterling Scarborough have never agreed to allow Box N Go and neither did my mother Karrie Gibson. My mother and I were illegally displaced from our home on September 23, 2020. I do gig work 10 hours a day to pay to live in a hotel, that is invested with roaches and bed bugs. My mother is deeply depressed. She has been under a doctor's care since around March/April of 2022. My credit was ruined because the City Of Industry Sheriff illegally breaking into our home putting my mother and I in the street during the height of Covid. I had Covid and long Covid in August and part of September of 2020. I didn't work for I was forced to use all of my money to pay for our stay at this hotel. My mother and I are attacked by bed bug every night. Some nights I sleep in my car. My mother has been prescribe several different medications. One of which is ambient. She has been taking ambient for over 16 months. *See*



*Exhibit L* copies of prescription's including anti-depressant, sleep aid and medication for attention deficient disorder. My mother is a good woman, who was in a 23-marriage year marriage with an abusive alcoholic. My mother stayed married to this man for over 23 years because she didn't want me, a black man to be a statistic. My sister received a merit scholarship to St John university, because my mother was "present" housewife and mother. My mother instilled values, and integrity. Because he is convicted in her faith, she believes God will be vindicator. What has happened to my mother is egregious and heinous. We are certain is because she is a black woman.

We have not seen our property in since 2020. Our home was 2715 square feet. My mother had wine cellar of wine valued over \$3000. My mother has an impressive bag, and shoe collection valued over \$100,000. My mother dinner set was over \$12,000 when purchased around 2010. My mother had fine and costume jewelry valued over \$30,000. There were 2 living room sets, values over \$9000. A piano, officer furniture a computer. I had a sneaker collection. Prior to covid I had T-shirt screen printing business. My Screen printer was over \$2000. We asked to court to order that Box N Go refrain from auctioning our property. We asked the court to order Box N Go to tell us where our property is and allow us to see our property and take possession. We asked that they judge inform the District Attorney that Box N Go is engaging in fraudulent.

# Exhibit A



Given your symptom presentation (fatigue, low mood, difficulty sleeping, anxious internal processing) in addition to your current context (being uprooted from your home, financial difficulties, legal trouble) it's only fitting that you would have trouble maintaining your attention level. Usually with depression, anxiety and trauma the brain is overloaded in such a way that it cannot sustain attention in the way it once did. This can also be because of specific chemicals that it may be producing less of (dopamine and serotonin) or more of (cortisol). Lets add to this that you have also had a previous head injury. I'm not a medical doctor so will encourage you to consult with one regarding how a head injury can also influence attention and memory. So if your body is in a heightened state physiologically (looking for threat) and also not being replenished by adequate sleep, then its going to have a lot of difficulty focusing. Part of the key is to improve your sleep hygiene work on mood management and expectations of what your brain is capable of doing in the present tense as opposed to in the past tense.

Unfortunately, depression is associated with several types of cognitive deficits and one area of deficit is in attention. An inability to focus in depression is common. In fact, "diminished ability to concentrate" is an official, diagnostic symptom of depression in the most recent version of the Diagnostic and Statistical Manual of Mental Disorders (DSM-5), the manual used to diagnose all mental illnesses. Combined with other common depression-related cognitive deficits, like impairments in memory and thought processing speed, depression and attention problems can make learning and retaining information very difficult.
